Each RSU represents the contingent right to receive one share of Class A common stock of the Company.
- Grant of stock options under the Plan. The stock options vest equally in 1/48 monthly installments commencing on March 9, 2022. The vesting of the options is subject to continued service for the Company, the terms and conditions of the applicable award agreement, and applicable tax withholding obligations.
